WHAT IS THE LINCOLN COUNTY RESOURCE BOARD?

The Lincoln County Resource Board (formerly the Lincoln County Children, Family and Mental Health Board of Trustees) was formed in May of 2003 by the Lincoln County Commissioners. Members of the Resource Board are appointed by the Lincoln County Commissioners.

The purpose of the Resource Board is to oversee the establishment, operation and maintenance of mental health services for children, youth and their families in Lincoln County. The LCRB also provides leadership in the development and implementation of early intervention, prevention and life skills programs.
