Seeing the world with 2020 Vision

Looking back over the last year, no one could have anticipated our collective journey.

We have invested in compassionate and innovative mental health providers; partnered with dedicated school districts; and benefit from a proven infrastructure of community partners and supports who will continue to Put Kids First in Lincoln County.

We will emerge stronger and more resilient because we have never lost sight of our mission: Our children, our families, our future.

2021: The Road Ahead

As we embark on a new year, we will build on our collective achievements and continue our progress, including:

- Hosting a Bridges out of Poverty "Follow Up" Session (to be held first quarter 2021) to spark community action for improved quality of life for our county's fragile families and a more vibrant, healthy and productive population for our county's future.
- Advancing programs the LCRB and its funded partners piloted through CARES Act Grant monies, including a school-based social worker for the R-III School District, greater investments in school-based mental health counseling, and launching CaseWorthy software (for referral tracking) to prevent our kids and families who are in crisis from slipping through the system's cracks.
- Enhancing community outreach initiatives, such as our Early Childhood Taskforce and Shower of Love campaign, which in 2020 alone collected 10,000 diapers and 15,000 wipes, and other baby care items, thanks to our community partners Mercy Hospital Lincoln and the Bank of Old Monroe.
- Continuing to invest in research and analysis--in 2020 the LCRB published its [Needs Assessment Report, developed by Dr. Cynthia Berry, featuring a county Key Findings Report and Missouri Student Survey outcomes](#)--to guide future funding allocations and ensure our funding is keeping pace with our children's and youth's evolving mental and behavioral health needs.




LCRB Announces 2021-22 Funding Allocations

The LCRB is celebrating one of our greatest gifts this holiday season: Lincoln County voters' approval of a 1/4 cent sales tax to fund mental and behavioral health services for Lincoln County kids.

During the November LCRB meeting, the board approved allocations of \$1,907,836.51 for the 2021-22, 18-month funding cycle. The one-time, 18-month contract period (from Jan. 1, 2020, to June 30, 2022) will allow the LCRB to transition from a calendar- to a school-year cycle to better keep pace with needs.

The funding will cover 10 non-profit agencies providing 17 unique programs and services for





Lincoln County kids, offered in a community, home or school settings.

Clinical outcomes include improved:

- Academic performance
- Behavior (at home and/or in the classroom)
- Daily functioning with reduction in symptoms, such as anxiety and depression
- Emotion regulation
- Coping skills
- Familial/peer relationships
- And, the reduction of substantiated hotline reports and homelessness in Lincoln County
